WHAT IS NOT COVERED

Components / Items:

- Correction of loose fasteners, squeaks, rattles and unusual noises.

- Adjustments.
- Items warranted by their respective manufacturers.
- Any part that is not a Navistar service parts or ReNEWed® parts.
- Aftermarket parts or service kits.
- Parts requiring replacement at inspection or adjustment maintenance intervals for reasons other than being defective.

Repairs:

- Maintenance-related items/repairs or those as a result of normal wear and tear, including tune-ups, gaskets, belts, seals, lubrication, an/ore other similar procedures/parts required to keep vehicle in good working condition. These services include, but are not limited to: oil changes, oil filters, air filters, fuel filters, cleaning/polishing, engine tune-up, adding oils, tightening of air intake and coolant clamps.
- Repairs to any part of the vehicle subjected to miss use, negligence, I am proper maintenance, and proper operation, or which is the result of an accident.
- Seals, wheel seals, gaskets, belts, hoses and lubricants, except when required in connection with a warrantable failure.
- Attaching accessories, thermostats, flex plate, externally mounted electrical & filtration systems.
